## PIKE TOWNSHIP POLICE LEVY

The Pike Township Trustees have partnered with the Village of East Sparta for additional police coverage through the Stark County Sheriff's Department. This partnership is currently for two years, and enables us to have a deputy on the road 40 hours a week, year-round, for both entities.

Pike Township has provided this with no additional levy to the Pike Township residents.

The Pike Township Trustees do not want to continue taking the funds out of the General Fund as this depletes the other uses for which the General Fund has historically been used. These uses include wages, roads, supplies, salt, black top etc.

We hope the residents will consider supporting a 1/2 mill Police Levy on the May 6, 2025 ballot. These funds will strictly be used for additional police coverage in Pike Township.

The same deputy year-round has benefited the Pike Township residents with proactive police coverage. The deputy has learned the area and the trouble spots throughout the township. This 1/2 mill Police Levy would cost the owner of \$100,000 home approximately \$18 annually.

# **ELECTRIC AGGREGATE**

The Pike Township Aggregation program has a contract rate of 6.96 kWh through June 2025 with Dynegy. We are currently negotiating a new 3-year contract, and are seeing local surrounding Townships rates to be around 8.20 to 9.00 kWh. Given the fact that there was such a sharp increase in cost for 2025/2026 capacity, we expect an increase in our rates. Our goal is to always help our residents save money. With the current Pike Township Aggregation program, participants have already saved a combined \$567,428.12.

This June, don't be surprised with a higher rate and maybe a new supplier. Residents that are currently in the Pike Township Aggregation program will not need to do anything. Residents can compare rates at Apples to Apples and switch at any time, but be careful with variable rates and short-term contracts. As always, there is an OPT out program with a fixed price.

zoning@piketownship.com to obtain information about the zoning permit that will be required.

Zoning was put into effect in Pike Township by a majority vote in 1962 and is an important part of our Township regulations. Zoning is designed to "promote public health, safety, morale, and general welfare" of the residents in Pike Township.
